Player Commitment:

I understand that:

- I am bound to the club for the entire playing year (September 1 through August 31) and may not move to another competitive club without a written release from Javanon.
- In order to obtain a written release from the club, all registration fees, past and present, must be paid in full.
- There will be a \$50 administrative fee for transferring to another club. This fee will be in addition to any fee required by KYSA.
- I am committing myself to participate in all team events. By not participating, my position on the team is in jeopardy and I can be asked to leave the team with no refund being offered.
- This is a competitive soccer program and the amount of my playing time is at the discretion of the coaching staff.
- If it is determined that I am exhibiting excessive aggression toward players, coaches, referees or spectators, I may be asked to leave an event.
- If I continue to exhibit poor sportsmanship or aggressive behavior, my future placement on the team may be jeopardized.
- I will ask my coach before committing to guest play for another team/club.

Parents Commitment:

I/We understand that:

- If it is determined that I am exhibiting excessive aggression toward players, coaches, referees or spectators, I may be asked to leave an event.
- I/we should always set a good example for our children and remain positive and supportive at team events.
- Javanon relies on volunteers. As such, a minimum of six (6) volunteer hours, per family, is required during the Fall, Winter and Spring season.
- Not fulfilling my volunteer duties will result in an assessment of \$75 per adult assessed immediately following the Javanon Cup in April. This assessment must be paid prior to my child's participation in state cup games.
- No refunds will be given except in cases of season ending illness or injury documented by a physician and prior to the season's first game. A \$50 processing fee and cost of uniforms, if purchased, will not be refunded.
- Expenses incurred by me and my family during travel weekends are my personal responsibility and not the club's.
- I understand that I will be responsible for fees for the Fall, Winter and Spring seasons.
- I understand that the Winter season (Nov-Feb) is a mandatory training season and requires additional fees to compensate trainers and pay costs associated with the daily overhead of the indoor facility. The winter fee also includes club membership for the period of August 1 through June 30 of each year.
- Soccer is a sport involving risks not encountered in everyday play. With this understanding, in consideration of the Javanon Soccer Club permitting my child to participate in the youth soccer program, I covenant and agree to indemnify and hold harmless and do release, requite and forever discharge the, Javanon Soccer Club, Kentucky Youth Soccer Association (KYSA) and the United States Youth Soccer (USYS) their officers, Boards of Directors, employees, coaches, referees and other such volunteers as are connected with the Javanon Soccer Club, KYSA and USYS in any capacity, for any and all damages, claims, and/or liability arising out of any and all injury to or caused by my child. With the knowledge and understanding of the foregoing, this is to certify that my child has my permission to play soccer in the Javanon Soccer program. Further, I hereby authorize any and all emergency medical treatment deemed necessary by any physician, nurse or paramedic. A copy of this authorization shall be as effective as the original.

Fees: Deposit is due at registration to hold player's spot on team. I understand that all fees paid are non-refundable and non-transferable (see policy above).
